- Discussion and/ or action regarding approval to amend Substitute Personnel, Policy GBRJ
  - Explanation- We would like to amend Policy GBRJ, Substitute
    Personnel, to allow for hiring substitute personnel in our Early Care
    Centers (Little Canes, Little Spartans and South Plaquemines Child
    Care Center) who are 18 years of age with a high school
    diploma.
    - Our Early Care Centers, Little Canes, Little Spartans and South Plaquemines Child Care Center, routinely struggle to find substitute personnel.
    - ii. <u>LDOE Bulletin 137</u> (LA Early Learning Center Licensing Regulations) has made provisions for staff to be hired or substitute while remaining in the supervising ratios if they are 18 years of age or older.
    - iii. In the proposed, <u>amended Policy GBRJ</u>, the added section (blue, underlined) shows added requirements for Substitutes in Early Care Centers. This policy revision has been vetted by Forethought.
    - iv. The requirements for substitute personnel for Head Start to12th grade remain unchanged in the amended policy (age 21).

 Recommendation - Amend Policy GBRJ to include Substitutes for Early Care Centers.
